1. QUALIFICATION CRITERIA:

- i. The Bidder should have connectivity from two or more ISPs, out of which one should be PGCIL.
- ii. The cumulative bandwidth available by the Bidders for the multiple provider should be at least 50 Mbps and above, out of which bandwidth from PGCIL should be a minimum of 30 Mbps.
- iii. The Bidder shall be an Internet Service Provider (ISP) or a franchisee of an ISP engaged in offering internet connection for the last 2 years.
- iv. The Bidder should have at least 2 (two) years experience in Setting-up, Operation & Maintenance of OFC based WANs with at least 100 nodes in Manipur.
- v. The Bidder should have a valid State VAT/ TIN registration certificate, a copy of which should be enclosed.
- vi. The bidder must be a firm registered in India for the last 2 (two) years as on date of submission of bid.

2. SCOPE OF WORKS:

- i. Distribution of bandwidth to the IT Firms at IT Park as per advice of DIT, Manipur for time to time.
- ii. To assure uptime of 99.5 %.
- iii. To make available a network Engineer on a 24 x 7 basis including at night for management of network issues, troubleshooting etc.

3. TERMS AND CONDITIONS:

- i. Installation period from date of Purchase Order will be 2 weeks.
- ii. Response for any connectivity issues will be within 1 hour and resolving the same should be within 2-3 hours.
- iii. To install a Network Management System (NMS) and manage the network at the IT Park building at Mantripukhri.
- iv. Payment will be on quarterly basis at the end of the every quarter.
